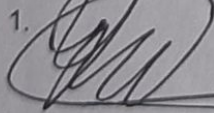

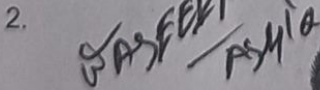
Assistant Director (Cons-IV)

To appoint Vakil advocate or change any advocate, solicitor, advisor regarding said case. To apply for copies of the documents relating to the said case and to receive the same from the court or from any other concerned office or department and to inspect records, to accept service of any summon, notice or writ issued by any court or office.
3. To file suit, petitions, and defend any proceedings/case in any court of law for this purpose, he is authorized to engage any advocate, to sign, verify and submit any plaint, written statement, application, affidavit, petition, objection, appeal, revision, review, writ petition objection, appeal leave to appeal, second appeal, to appear in the office of civil/criminal courts of jurisdiction, revenue courts, appellate/revision jurisdiction, High Court and Supreme Court of Pakistan and all other relevant forum regarding the above said titled case.

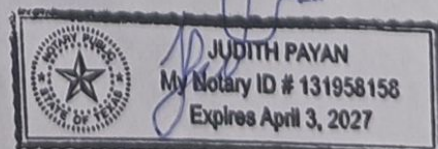

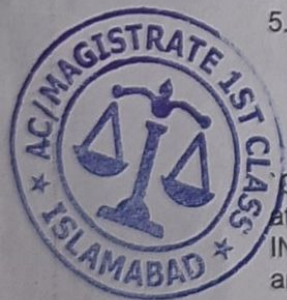

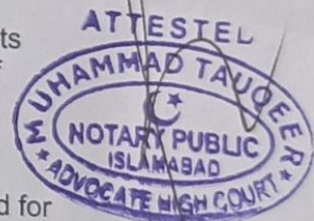
